

Data Protection Consent Form for Athletes

regarding the transfer of the World Para Snow Sports
to International Ski and Snowboard Federation

August 2022

The International Paralympic Committee, Adenauerallee 212-214, 53113 Bonn, Germany (“**IPC**”) has transferred the governance of Para alpine skiing, Para snowboard and Para cross country skiing to the International Ski and Snowboard Federation, Marc Hodler House, Blochstraße 2, 3653 Oberhofen / Thunersee, Switzerland (“**FIS**”).

The IPC has transferred the governance of the sport of Para biathlon to the International Biathlon Union (“**IBU**”). Para biathlon will be integrated into FIS’ general Para sport initiative and managed by the IBU in cooperation with FIS through a joint Steering Committee.

This Data Protection Consent Form (“**Form**”) documents my consent to the transfer of certain data governing my participation in all World Para Snow Sport competitions excluding the Paralympic Games and the Paralympic Winter Games (“**Competitions**”).

The Form requires your consent as set out below in order for you to remain eligible to compete in Competitions going forward. Subject to any alternative arrangements you make with FIS, you will not be eligible to continue competing in World Para Snow Sports until you have signed and returned this Form.

Consent to Transfer of Non-Public Personal and Health Data

To facilitate your continued participation in Competitions, your consent is required to the transfer to the FIS the non-public personal and health data previously collected by the IPC.

Without your explicit consent the IPC will not grant FIS any access to your non-public personal and health data, so no transfer of non-public personal and health data to FIS will take place. This will mean that FIS is unable to facilitate your ongoing participation in Competitions, and you will be ineligible to compete in the World Para Snow Sports, subject to any alternative arrangements you make directly with FIS.

Consent to Simultaneous Transfer of Public Personal and Health Data

In addition, if providing your consent prior to 29 August 2022, you also consent to the transfer of your public personal and health data previously controlled by the IPC at the same time that your non-public personal and health data is transferred to FIS.

Having read the above, I freely agree that the IPC may transfer my non-public personal¹ and health² data related to World Para Snow Sports to the FIS for the purpose of the governance change and in order to facilitate my participation in World Para Snow Sports competitions in the future.

In addition, if providing my consent prior to 29 August 2022, I also consent to the transfer of my public personal and health data³ at the same time that my non-public personal and health data is transferred to FIS.

I can revoke my consent in whole or in part at any time. I can declare the revocation by contacting privacy@paralympic.org. Data processing carried out based on this consent prior to my revocation will continue to be lawful.

If I do not give this declaration of consent, a transfer of my non-public personal and health data will not take place and I will be ineligible to compete in the World Para Snow Sports, subject to any alternative arrangements I make directly with FIS.
